Generalities and novelties

- Participants become CSCQ-members, when paying the annual fee, which allows to participate in interlaboratories trials (EQA-surveys). The programmes are billed separately at the beginning of the year and for the whole year. The CSCQ financial year starts on 1st January and finishes on 31st December of each year. The financial year of the EQA-Centres with whom CSCQ has developed collaborations, UK NEQAS and GenQA, starts on 1st April and ends on 31st March of following year. Subscription during the year is billed pro rata of the carried-out surveys.
- All CSCQ programmes submitted to legal requirements are recognised by the QUALAB and belong to the CSCQ scope of accreditation.
- This price list is part of the CSCQ-registration conditions. Italian participants have to refer to the price list from our distributor in this country, Tema Ricerca.
- Since 2024, the EQAcom fees include the participation to the pre- and post-analytic programm. We encourage all members to participate to these formative surveys, which are important for the work in the medical laboratory.
- The CSCQ faced in 2024 again many price increases, as for instance the control samples, transports, bottlings or cardboards. As a non-profit organisation, we have to pass on these increases on our own prices. Many programmes are concerned. The programme prices proposed by the EQA-Centres with whom the CSCQ has collaborations did also increase, but, due to a favourable exchange rate, to a lesser extent than the real increases. Please consult our specific programme sheets. In case of a sudden exchange rate change, the CSCQ can increase some prices. If necessary, this could even happen during the year. Please see the updated price list on our web site.

EQAcom: for the transfer of your results and the receipt of your reports electronically

- The electronic transfer of your results via Internet allows an important cost saving in your favour. The use of our software EQAcom is user-friendly and more than 95 % of the members have already adopted it.
- The use of EQAcom makes the transfer of the results and the consultation of the reports, which are available for 12 months, simple. They can easily be archived, and the traceability of the results is achieved. The certificates as well as the invoices issued by the CSCQ are also available on EQAcom.
- For participants located outside Switzerland the use of EQAcom is compulsory.
- Laboratories wishing an extra paper print of their reports in addition to the ones available electronically, will be charged on the basis of the rate for extra report copies.
